
Full circle

From The Command Track

n November 11,

2007, we learned of the death of our dear friend

and president of the 11th

ACVVC, Chuck Schmidt.





As president pro-tem, I am pleased to report that the overall state of the 11th ACVVC is excellent. We continue to be successful in many areas; scholarships, reunions, treasury, membership, quartermaster, website and newsletter to name a few.

In June 2007, Chuck was diagnosed with cancer. This was his second bout with cancer, having overcome this disease in 1996. The prognosis this time was that the cancer was not curable but controllable through chemotherapy. Chuck received one chemotherapy treatment in mid August, a few weeks prior to the Louisville reunion.

Despite the lingering side effects of the chemotherapy, Chuck attended the Louisville reunion in September. He was determined to perform all duties as president. Many were willing to step in at a moments notice to provide some relief but somehow he found the strength and inspiration to carry on his duties.

During the reunion Chuck gave an update on his health. He felt confident the cancer would be controlled. We were optimistic and encouraged by his decision to run for president and serve another two year term.

Shortly after the reunion Chuck developed a serious infection. He was being treated with antibiotics and his condition was improving when he suddenly took a turn for the worse. A further examination revealed another tumor. On November 11, 2007, he passed away peacefully at his home in Colorado Springs. His wife Bonnie, son Garrett and daughter Jill were at his side.

Chuck had many assignments during the 27 years he and his family served on active duty. As a cavalry officer he proudly served

with the 10th Cavalry and 14th Armored Cavalry Regiment. As a captain in 1967-1968 he served as troop commander of I Troop, 3rd Squadron, 11th Armored Cavalry Regiment in Vietnam. This was perhaps the most difficult and challenging assignment of his military career, yet it was this time that he cherished above all.

Chuck was a proud Blackhorse trooper. He was proud of the men he served with in I Troop and of the many Blackhorse troopers he met during his involvement with the 11th ACVVC. He was a great leader both in the Army and as president of this organization. He was also a great friend and we will miss him.

Chuck served two years as a board member and nearly four years as president. To honor Chuck's years of dedication to the 11th ACVVC and in particular his dedication to the constant improvement of the Scholarship Program, the Charles L. Schmidt Memorial Scholarship has been established. The scholarship will be awarded yearly to the top ranked applicant based on combined scores from all judges. The amount of the scholarship will be determined by the Board of Directors.

Chuck was to begin his third two-year term as president of the 11th ACVVC on January 1, 2008. With Chuck's passing, a vacancy was left in his position. Article VII, Section 4(a) of the 11th ACVVC by-laws

outlines a process for filling such a vacancy:

In the event of a vacancy in any office, or inability or refusal to serve, the office shall be filled pro tem by a majority vote of the remaining Officers.

On November 21, I was elected by the remaining board members to fill the position of president until the next general membership meeting on August 23, 2008, during the next reunion. This action resulted in a vacancy in the vice president position. On November 26, the board members elected Pete Walter to fill the vacant position of vice-president. Pete was elected as vice-president during the general membership meeting in September 2007. His two year term would have started January 1, 2008.

As president pro-tem, I am pleased to report that the overall state of the 11th ACVVC is excellent. We continue to be successful in many areas; scholarships, reunions, treasury, membership, quartermaster, website and newsletter to name a few.

The scholarship program is thriving with record levels of donations. In 2007 the combined fundraising activities from our calendar, raffle and silent auction allowed us to award scholarships of \$3,000 each to 32 of our children for a total of \$96,000.

The first leg of our 2008 Scholarship fundraising effort was mailed to all members in December. The 2008 11th ACVVC Calendar once again featured 12 new photos submitted by you. The calendar also contains significant historical events of your regiment in Vietnam.

Our Scholarship Fund is self sufficient. That is, all scholarship awards as well as all printing and mailing cost associated with the calendar are paid directly from the scholarship fund. The calendar is not part of membership dues. I once again appeal to your generosity as we ask for donations to support our Scholarship Program. Your continued support has enabled our Scholarship

ey folks, did you know that as I write this there are 220 more days until our reunion in the Windy City? That's Chicago in case you didn't know.

It's never too early to register! It is so important to get your information in as soon as possible. I know you're saying, "What's the rush? I have lots of time". Well, the sooner you get your registration in the quicker I can get your packet put together and therefore, Barb, Raleigh and I are not having to pull all niters the couple of days prior to reunion to get everything done. When you have over 700 packets plus name tags to do (plus everything else that is required to pack, to get ready to go), it really can get hectic around here.

So as soon as you see the registration form either in *Thunder Run* or on the web site fill it out and get it in the mail or send it via the web site, to Ollie. When filling them out, remember to use those little name labels that you get in the mail all the time. They make it so much easier on Barb when she has to start typing up the name tags and such.

If you are a Next-of-Kin please be sure to indicate this somewhere on the registration form. Also please keep nicknames to a minimum. It is very difficult to fit your name, nickname, unit/years, and where you are from on the name tag. We try very hard to get everything you want on them but if Barb has to shorten something, then it's usually the nickname that is the first to go.

On the same note, just because you live in the vicinity of the reunion, please don't feel that you can just show up without pre-registering. It makes everything more difficult as you will be asked to pay an additional late registration fee, or you may not get to attend the banquet. Along the same lines, if you show up and I do not have your information or packet, you will be required to pay a late fee. This goes

This issue of *Thunder Run* is being mailed to over 16,000 Blackhorse troopers on our mailing list, including members, lapsed memberships and those who have not yet joined.

If you haven't yet become a member of the 11th ACVVC, or if your membership has expired, this is a good time to take a minute and become a member or renew your membership.

If you are not sure of your membership status in the 11th ACVVC, take a second and check the mailing label on the back page of this newsletter. Look for these words:

FREE COPY or EXPIRED

If the words "FREE COPY" are printed on the first line of the label, take this opportunity to join and become a member. If the words "EXPIRED" are printed, you should take a minute to renew your membership. Expired members will also have their membership number printed on the same line.

There may be some confusion about membership in this organization, the 11th Armored Cavalry's Veterans of Vietnam and Cambodia (11th ACVVC) and the Blackhorse Association (BHA). They are two separate organizations, each with their own charter, by-laws, officers and membership dues. Many of us are members of and support both organizations. Some of the people we have contacted for membership renewal have written back and furnished a copy their LIFE membership card only to discover it is not from the 11th Armored Cavalry's Veterans of Vietnam and Cambodia (11th ACVVC).

Over 19,000 of the estimated 24,000 who served with the 11th ACR in Vietnam have been located or accounted for (80 percent). Over 8,100 of the 19,000 have joined the 11th ACVVC since it was formed in 1986 (42 percent).

To join or renew your membership in the 11th ACVVC just fill out and mail the membership form printed in this newsletter. Make sure you give your full name, address, service number, unit(s) and dates in country (month/year). This will help us match you with others that served in the same unit. We also encourage you to sign the release line at the bottom of the form. This gives us permission to give your address and/or telephone number to other troopers who may be looking for you. Your name, address, etc are NOT sold or given out to vendors or anyone other than Blackhorse troopers.

Membership dues are only \$15 per year, or \$100 for a LIFE membership. We also offer an easy and convenient LIFE payment plan which divides the \$100 membership dues into four payments of \$25 each. We also accept Visa and MasterCard credit cards for all transactions.

Your membership dues provide you with this quarterly newsletter *Thunder Run*. The newsletter keeps you informed of your organization, its members, and the activities of the 11th Cavalry, both past and present. We pride ourselves on our continued commitment to bring the news to our members through this newsletter.

Thunder Run has been printed and mailed every three months for the past 22 years. This shows our reliability and commitment to our members.

A small portion of the dues is used to support these special projects:

- Support to locate other Blackhorse troopers (paper, envelopes, and postage. Labor is free!).
- Support for Memorial Day / Veterans Day activities. The organization places a wreath at the Vietnam Veterans Memorial to honor the 729 men of the regiment whose names are on the Wall. We turn fast into the jungle woodline. My ACAV hits an anti-tank mine so powerful it flips it upside down. I come out of it unscathed, but I know if I let go of this tree that I can't seem to let go of, it will all happen again.

We have the ownership, the courage, the hope, the horror, the confusion, and the consequences that are embedded in our hearts. Together then, Together again, we are ready to turn fast... into the jungle woodline.

Association (VHPA). Gary Roush has compiled a database of most, if not all Helicopters flown during the Viet Nam years. The information contained here is nothing short of amazing. This database was the source that finally enabled me to track and ultimately find my UH-1, the 528. Ironically, it was right here, near where I worked, at Oro Grande Base Camp, New Mexico. I had often looked at these old helicopters but never dreamed mine had been among them. So, finally after tracking it in the database, I found that the 528 was located at Yuma Proving Ground, Arizona.

Saving The Yano, 528.

In January, 2000 I contacted Rick Douglas at Yuma Proving Ground in Arizona to verify that he, in fact, had possession of 528. After introductions by email I found Rick to be very interested and cooperative concerning my desire to visit and actually experience seeing this old war bird. He told me it had a destiny to wind up as a target for aerial gunnery in the near future but he would hold off on this Huey until I could get there. I continued to work with Rick at Yuma and Brian Howard at the War Planes Museum, New York to acquire 528 as a donation to that museum. Gary Roush had introduced me to Brian as the Curator at War Planes and the person I should work with directly.

I made my trip to Yuma on May 19, 2000 to actually make visual and physical contact with my old Gun Ship no matter what condition it was in. Chuck Wullenjohn, Public Affairs Office, came out and conducted an interview and published an article, "Comrades in Arms" about my reunion with 528 in the Yuma Daily Sun. I also met Mike Thompson, Yuma Museum Director, who was also extremely helpful with this recovery. After my visit we continued to work the donation procedures until, finally, in November, 2000 528 arrived at War Planes Museum, New York. My visit to Yuma, reunion and article can be verified by contacting the Public Affairs Office at Yuma Proving Ground, Arizona. I also have copies of the article.

Transfer of the Yano from War Planes to Ft. Irwin

After the events of 9/11 in 2001 projects such as these were put on hold due to budget constraints in New York. I also had some personal issues that took me out of the loop for some time. So the events that took place in moving 528 to Ft. Irwin are not clear to me. But I was contacted by CW4 Rick Bebb by email referencing a request for parts for the Yano. This was sometime in early 2003 and the first time I knew it was now in Barstow at the Dagget Airport, Through Mr. Bebb I met Bill Heidner and he was working and assisting in restoring the Yano. I made a trip to Barstow and Fort Irwin in late April 2003 to meet Bill and Rick as well as see 528. I also met Neil Morrison at the Museum while I was there. The restoration project

seemed to slow due to some internal funding and personnel issues. Rick Bebb and Bill Heidner were transferred and so I again lost contact with the project.

On June 8, 2007 I received an email copy from Gary Roush. In this email he was explaining some of these events to Sherri Bratt and he gave her my email address. Sherri and I corresponded by email and I gave her information about 528 back in the day, Air Cav Troop, 11th ACR, RVN, 1967 – 1968. I had planned to meet her when I made my visit to Fort Irwin in July 2007. She was on leave, however, when I arrived and so Neil Morrison, Museum Director, met with me and gave me a personal and much appreciated tour of 528 and the 11th ACR Museum

As I have indicated 528, The Yano, was not discovered by unnamed retired 11th ACR Vets at an unnamed private museum in New York. It is unfortunate that I was unable to meet with Sherri Bratt as I would have been able to relate to her the true recovery story of this famous UH-1C Gun Ship. My reason for this article is to give the accurate story of recovery and credit to myself and to those who were instrumental in saving 528, the Yano. Those people are: Rick Douglas, Mike Thompson, Gary Roush, Brian Howard, Rick Bebb, Bill Heidner, and Neil Morrison.

The Yano is currently a work in progress, we are not done with her yet.

Going to Sea Part II

Tenjoyed the Thunder Run article "H **■**Company goes to Sea" by Joseph Gibbs. It brought back some of my own memories about that trip, and thought that I would pass along some of my own experiences.

Like H Company, E Troop loaded onto an LST in Saigon in April 1967. After many convoys escorting between Blackhorse Base Camp and Long Binh, we were rather paranoid about where we might find Charlie. I expected to see him behind every bush. As we were sailing down the Saigon River, leaving the urban area of Saigon, the riverbank looked like an excellent place for Charlie to place an ambush. Looking around the deck of the ship, the only defensive armament that I noticed was the .45 on my hip. I went down to the hole of the ship, retrieved an M-60 from one of my vehicles, and set it up on the deck. Well, I guess many ships sailed up and down the river every day without incident, and I didn't need that machine gun.

The LST was a US Navy ship crewed by foreign nationals. Ron Kelly, 1st platoon leader, and I have discussed this trip since then, and we disagree on the nationality of the crew. He remembers them as being Korean, and I remember them as being Japanese. Ron is probably correct. With the limited role that the US Navy played in this conflict, compared to Army, Air Force, and Marines, I don't know why the Navy could not crew their own ship.

The ship only had mess facilities for the ship's crew, so we had cold C-rations three times a day for the entire trip. After about that third day, cold C-rations tend to get a little old.

While out in the South China Sea, Captain Geoff Moakley, Echo Troop commander, devised an activity to relieve our boredom. He decided that we should test fire all of our machine guns. One at a time, each vehicle crew brought up the machine guns from their vehicle and test fired them into the ocean. This exercise intrigued the ship's civilian crew. We made their day by allowing them to fire a few rounds.

After landing in Chu Lai, we unloaded Continued on page 30

GUIDE TO THE 11TH ACVVC SCHOLARSHIP PROGRAM

Updated January 21, 2008

11th Armored Cavalry Veterans of Vietnam and Cambodia

Scholarship Chairman Frank R. Cambria; Scholarship Co-Chairman Michael "Doc" Rafferty



Scholarship applications for each school year beginning in September must be received by May 15 of the same calendar year.

The following information is provided to help our members and their children understand how our Scholarship Program works and how the program was developed.

THE 11ACVVC SCHOLARSHIP AWARD

The amount and number of Scholarship Awards may vary from year to year. In 2007, 32 Scholarships of \$3,000 each were awarded. 11ACVVC Scholarships are for *undergraduate studies* only. Scholarship Awards will be paid directly to the recipient's educational institution for expenses incurred up to the total amount of the award. Additional Scholarship Award information may be found at the 11ACVVC website: www.11thCavNam.com.

Effective for 2008, one recipient will be selected to receive a special Charles L. Schmidt Scholarship award in honor of former 11ACVVC President Chuck Schmidt for his leadership and his complete dedication and devotion to the Blackhorse Troopers of the Vietnam War. Chuck died in 2007 as a result Agent Orange related cancer shortly after being elected to his third term as President.

THE CRITERIA FOR APPLICANT ELIGIBILITY

There is no age limit for eligibility. Those eligible to apply are:

- Children and stepchildren of current members of the 11ACVVC in good standing.
- ◆ Children whose legal guardian is a current member of the 11ACVVC in good standing.
- Children of 11th Armored Cavalry "Blackhorse" Troopers who were KIA or died as a result of the Troopers' service in Vietnam.
- ◆ Troopers themselves, if qualified, who are current members of the 11ACVVC in good standing.
- Grandchildren of members are **not** currently eligible. This criterion is being reviewed annually.

Applications may also be accepted from applicants whose fathers' membership has lapsed by requesting the father's reinstatement and paying one year's membership fee.

Applicants whose father is a Blackhorse veteran who served in Vietnam or Cambodia but is not a member the 11th ACVVC, may apply after their father joins the 11th ACVVC.

HOW TO APPLY

The applicant must fill out the Scholarship Application Form completely and attach Grades and Narrative. The Scholarship Co-Chairman must receive the completed Scholarship Application and grade transcripts of the applicant **no later than the deadline of May 15** of each year or any announced extension of that date.

The Scholarship Application Form is available on the association website at www.11thCavNam.com. An Application may also be requested by mail or email from the Scholarship Co-Chairman or Chairman.

JUDGING

Scholarship Applicants are judged in three categories:

- I. Form completion, legibility and following instructions
- II. Grades

III.Typed narrative response to questions in item #11 of the 11ACVVC Scholarship Application

The Scholarship Committee may offer a priority of Scholarships to Children of those Vietnam War Blackhorse Troopers Killed In Action (KIA) or Died of Wounds. These are the only criteria that could take precedence over judged items I through III above.

The Scholarship Chairman and Committee Members select the Judges. The main considerations for selection of Judges is that they must be impartial, educated, readily available, and have an excellent understanding of what it takes to succeed in College.

The judges are asked to rate each applicant awarded for Items I and II above. The remaining 15 points are allocated to the narrative response for Item III on a point system. The point total for a perfect score is 30. Up to 15 points may be above.

Judges' scores are totaled. Applicants are then listed in descending score order. The 11ACVVC Board of Directors will stipulate the number of Scholarship Recipients in advance. The judges will apply that number to the list of applicants in descending score order to determine who will be the Scholarship Award recipients. The recipient with the highest score would receive the special Charles L. Schmidt's Memorial Scholarship award. In the event of a tie for the highest point score, a designated representative or family member of deceased Colonel Charles L. Schmidt will select one recipient based on criteria of her/his choosing. Currently, the designated family member is Colonel Charles L. Schmidt's widow, Bonnie Schmidt. The amount of Charles L. Schmidt's Memorial Scholarship will be designated separately by the Board of Directors

All Selected Recipients of the 11ACVVC Scholarship will be notified in writing by the end of June. The Recipient's notification letter will include instructions to arrange for the Scholarship Funds to be sent to the Educational Institution the Recipient is attending.

HISTORY OF THE 11ACVVC SCHOLARSHIP PROGRAM The membership decided at the 1996 Reunion 11ACVVC Membership Meeting to form a Scholarship Committee to establish a Scholarship Program exclusively for 11th ACVVC members, children of our members, children of our KIAs, and children of our deceased members. The program has evolved and grown over the years. As of 2007, 219 scholarships totaling \$550,000 have been awarded by our membership to deserving students.

FUNDING. Primarily member donations and fund raising activities within the 11ACVVC membership fund the Scholarship Program. The annual fund raising activities include donations received for the Blackhorse Calendar, a Raffle, and a Silent Auction held each year at the annual reunion. The 11ACVVC Scholarship Program is intended to benefit all qualified people associated with 11ACVVC membership.

Thunder Run 1st Ouarter, 2008

We will continue to award Scholarships as long as our membership supports the Program.

The Board of Directors voted in 2001 that a portion of the income generated from the Association's investment accounts may be used to help fund the Scholarship Program. During the 2001 Scholarship season, it was decided that the intent and spirit of the 11ACVVC Scholarship Program was to benefit the children of all members - and members themselves if qualified. After a long discussion, the consideration of financial need was removed from the criteria.

The Board of Directors voted in January 2006 that the 11th ACVVC Scholarship program would limit awards to undergraduate students only. **Graduate and Doctoral level students are not eligible.**

We thank the thousands of Troopers, their supportive families and loved ones, and all who have contributed so generously over the years to make this program a success. All of us together, contributing what we can, have helped make this program one for which we

can all be proud.

Vietnam Veterans Share Memories

anda Kirk Hinnant was just 2 years old when her father, James J. Ruffin was killed in Vietnam. She grew up hearing stories about her young father, but she wasn't old enough to remember anything about him. Forty years later, she's thankful to be learning another side of her dad, and she's thankful she gets to look at him in pictures every day.

A few months ago, Larry Burwick of Cleveland, Texas, made contact with Wanda and her uncle, Charles Ruffin. Charles is James' younger brother. Larry wanted to share some stories and photos of James.

Larry and James served together in the 2nd Platoon, I troop, 3rd Squadron, 11th Armored Cavalry Regiment in Vietnam in 1966 and 1967. The two soldiers traveled to Vietnam on the same ship, did platoon training together and were both assigned to be drivers.

Although they weren't on the same vehicle, they did spend time together and got to know one another. Larry and the entire regiment suffered a huge loss when James was killed March 19, 1967.

Years after the war, Larry starting making an effort to locate guys in I troop. Several were reunited, and they often thought about James and wondered about his family. Larry knew James had a small child and knew a little about his family. He knew he was from Wilson.

Larry called Ruffins listed in the phone book but never had any success. He'd wait a year or two and then try again. When he got connected to the Internet, things got easier, Larry said. He decided to make a real effort to locate the Ruffin family.

He searched Wilson, North Carolina, and got contact information for funeral homes, cemeteries and the newspaper. He called the *Daily Times* first and was directed to Edwards Funeral Home, the funeral home that we thought probably served the

Ruffin family when James was killed. Larry called and spoke to Sandra J. Barnes at the funeral home.

"He said 'I was wondering if you could help me,' and I knew exactly who he was talking about," Sandra said. "I remembered they stayed on Pender Street, so I told him, 'Yes, that I knew the family." Sandra was a student at Darden High School at the time James was killed. You don't forget events like that, she said.

Sandra contacted Charles, and he and Larry got in touch with each other. "It felt pretty good because I had not heard anything in so many years," Charles said. The last memory he had of his brother was the military notice that he had been killed.

Larry shared two snapshots he had, one of James and one of the ship that took them to Vietnam. He also had very kind words to share about James. "We were there. We had a job to do. We did dirty jobs, beating jungles. He always maintained his vehicle. He was jovial. He was a hard worker, never complained, easy to get along with. He always had a smile on his face. He was a top-notch man and a good solider." Those words mean a lot to Wanda." I'm still excit-

ed about all of it," she said.

Larry also contacted the group he is a member of, the 11th Armored Cavalry's Veterans of Vietnam and Cambodia, to see if any of those guys had any pictures or stories to share with Charles and Wanda. They got more pictures, and one man, Lance Hembree, called Wanda and told her all sorts of stories about her father. Hembree served on the same vehicle as James.

"He was my dad's partner," Wanda said.
"He told me some things about my dad that I did not know. It was so exciting to hear things about him. Hembree was with him until the end."

"It made me feel special that (Larry) was looking for us all these years," Wanda said. "That was very special."

Larry told Charles and Wanda all about the 11th Armored Cavalry's Veterans of Vietnam and Cambodia, invited them to be honorary members and added them to the group's mailing list. Both have indicated they would like to attend a reunion soon. Kudos to Lance Hembree and Larry Burwick (I Trp 66-67) for taking the initiative to locate James J. Ruffin's daughter and brother. — Editor

A Great Way To Go

s I write, I've just returned to Texas Afrom the memorial services for Chuck Schmidt in Colorado Springs. Chuck was our great and beloved president and leader. As president he was elected, again, this past September at our twenty-second annual reunion. As leader, he was our own, a true leader among men. He was elected by an enthusiastic and unanimous vote, as it appeared to me. Chuck was determined to make it through another term. He didn't make it this time. He won the first bout but Agent Orange cancer won this one. It was his time to go. And go he did - in grand style as befitting the finest of cavalry, in the saddle with his boots on and his family and troopers at his side.

Until now I hadn't fully realized in how grand a style Chuck was leaving this life and entering eternal life with his Lord and his forebears. As I listened to many testimonials about Chuck, I came to realize what sort of man I had known and shared with. More will be said by the words of others who were there, by others who knew him, from tributes in our Thunder Run, and by sharing at our reunions. I'll say that, except for leaving this life too soon, I'm confident that Chuck went out in exactly the way he wanted. Who could ask for more?

According to those who shared on his behalf, Chuck was what greatness is made of: as husband, dad, grandpa, neighbor, Army leader in combat and in peace, in his neighborhood, in his church, playmate with his grandkids, mentor and role model for teen-agers, and more than can be put into words or that I would even know. One mark of his greatness is learned from his grown kids. His daughter talks about how she had grown to know her dad so much deeper and in ways she hadn't known when she came to our reunion and experienced how remarkable Chuck was around his Blackhorse brothers. The same thoughts and insights came from the hearts of others of his family and close civilian friends.

Chuck had a beautiful home on high ground at the western edge of the

Colorado plains that looked toward his beloved Air Force Academy. The home he provided was shelter and sanctuary for his family as well as for himself. But, more: their home was a sanctuary and a lighthouse for his neighbors, his vets, and others I have no way of knowing about. From those invited into his home I know that he and his dear wife, Bonnie, opened their doors to many, of which I was one. At his memorial service testimonials were profuse in attesting to what I'm saying.

One of Chuck's virtues that stood out I mentioned at his memorial service. Chuck was proof that, with our 11th Armored Cavalry Veterans of Viet Nam and Cambodia, the ground is truly level. Our founders were junior or mid-grade enlisted men. Our first two presidents were enlisted men (I think sergeants). I don't know if they were drafted or volunteered, but I know that they weren't career. On the other hand. Chuck was a retired full colonel with a career of 27 years active duty. But you wouldn't have known it. My observation, right or wrong, was that many of our members didn't even know Chuck was a colonel for a long time. It just didn't matter. As I said, the ground is level in our organization. Now we count as members former junior grade enlisted men all the way up to retired four star generals. Each is appropriately respected. Here the respect works both ways. The fact is, it's usually not easy to know who was what back in the old days. Here we are brothers - that's it. Officer and enlisted days are gone. No more orders are given. Brotherhood is here to stay. Chuck proved the point. Chuck was great and loved because of who he was - not because of what he had been. It was what he wanted. It was what we all wanted. It's a grand part of his legacy.

Chuck's life was full to overflowing. Chuck saw to it that God had priority in his life. He didn't just attend his church there in Monument, Colorado, he was fully a part of it. He took leadership roles. He took "followership" roles too. He was a true servant as well as a true leader - he knew they went together. He loved and was loved. He loved the Lord. He worshipped Jesus his Christ. The testimonials of his fellow church members as well as his priest were clear as to how committed Chuck was to his church and his Lord. As chaplain for our organization, I know how deeply Chuck lived his faith. I'm sure you know too. Chuck lived his faith openly without being forceful or obnoxious about it. Anyone could see clearly that Chuck was what he said. His words and his acts were on the same track. He led from the front, in his faith and character as in his relationships and positions.

One of Chuck's last acts of leadership reflected one of his passions and visions. That was the restoration of our 11th Armored Cavalry Regiment monument at Fort Knox, Kentucky. The re-dedication of the monument and all the events of that wonderful week end were a focus of his leadership and a profound statement of what his life was all about. The reunion. its events, its brotherhood, and its families were truly an "apex" and powerful symbol of what we're all about. So many worked so hard and contributed so much to the event that the reunion in Fort Knox became a real tribute to Chuck Schmidt and our purpose as an organization. Chuck would not, in any way, be willing to "hog" all the credit. With him we all recognize that so many gave so much to make the rededication of our monument and the week-end such a success. Now we pay tribute to Chuck, our leader and inspiration for that wonderful event.

It's fitting that I quote from the Scriptures that were read at Chuck's memorial service. They were selected by his family. They honor him and demonstrate what his family had to say on his behalf as a genuine Christian man. The

words are from Romans 8:31b-35: "If God is for us, who can be against us? It is God who justifies. Who is he that condemns? Christ Jesus, who died — more than that, who was raised to life — is at the right hand of God and is also interceding for us. Who shall separate us from the love of Christ? Shall trouble or hardship or persecution or famine or nakedness or danger or sword?" Verses 38-39 finish the passage: "For I am convinced that neither death nor life, neither angels nor demons,

neither the present nor the future, nor any powers, neither height nor depth, nor anything else in all creation, will be able to separate us from the love of God that is in Christ Jesus our Lord."

So I say, "What a Great Way to Go!" Chuck, you went too soon, but you went well. We'll miss you, brother, but we will not forget you. You'll be around until the last man turns out the lights.

Allons, our brother and our leader. Allons!



Circle of Honor and Memorial Bricks

After four years of research, planning and preparation, the 11th Cavalry Memorial at Fort Knox, KY, was rededicated during a ceremony on September 8, 2007.

The centerpiece of the memorial area is the Vietnam Memorial, originally dedicated 40 years ago in 1967. During the months preceding the rededication, minor repairs were made to the memorial. The four bronze plaques listing the names of our 729 KIA's were replaced. Three new memorials (obelisks) were also added to honor the 11th Cavalry Troopers who served in other wars and campaigns beginning with the Philippine Insurrection in 1902-1904, through the latest deployment in support of Operation Iraqi

Freedom III in 2005-2006.

The memorial project was funded in part by the sale of granite bricks. The "Circle of Honor", the area surrounding the monument, consists of approximately 1,100 granite bricks that can be inscribed with any appropriate message. The bricks add a very special and personal touch to the memorial. Many chose to have their name, unit and years of served with the regiment inscribed on their brick. Some of the messages are very touching: "BROTHER & UNCLE-WE REMEMBER", "BROTHERS 4-EVER", "I NEVER FORGET", "SOLDIER HUSBAND DAD GRANDPA U R MISSED" and "ALL GAVE SOME-SOME GAVE ALL" are just a few of the personal messages on the bricks.

Journey to Fiddler's Green



our vehicles and moved to relieve a Marine unit at an FOB in the area. The Marines had a hot meal for us, our first since leaving Blackhorse base camp about a week earlier. The Marines had a well-fortified camp, with dug in fighting positions around the perimeter. A destroyed Marine amphibious tracked vehicle was just outside the perimeter, giving evidence of earlier activity in the area. Before our mission was complete, some of our vehicles would also be destroyed. We began to defend the area by sending out daily patrols. The VC snipers in the area were a bit more active around Chu Lai compared to the area where we had been operating. I attributed that to the fact that these snipers had not yet experienced the heavy volume of firepower that our ACAV's unleashed when fired upon.

I was only with Echo Troop for about two more weeks after landing at Chu Lai. While out on a dismounted patrol, I happened to be too close to one of Charlie's booby trapped grenades when it went off, and was air evacuated to Camp Zama in Japan, the end of the war for me.


